



## HEALTH GRANTS PROGRAM REQUEST FOR LETTER OF INQUIRY (LOI)

### BEHAVIORAL HEALTH FIRST QUARTER 2022



#### **Granting Priorities**

Reflecting its purpose of promoting health and education for the residents of Weld County, The Weld Trust requests proposals for projects and programs that address the current priorities and goals identified by The Weld Trust.

**In accordance with The Weld Trust's vision to help Weld County become the healthiest County in the State of Colorado, the first quarter 2022 Health initiative is focused on:**

#### **Behavioral Health**

*The Weld Trust will work with nonprofit agencies, schools, and government entities throughout Weld County to fund behavioral and mental health resources for children, youth, and families in need.*

- *The Weld Trust will fund the development of programs for youth in Weld County that focus on mental wellness.*
- *The Weld Trust will also fund crisis intervention resources and services.*

In addition, The Weld Trust gives priority to projects that:

- Address underlying social and economic challenges contributing to poor health outcomes in the communities served, such as poverty.
- Extend past individual behavior or program-related services by modifying policies, systems, and environments to help make healthy options practical and readily available.
- Demonstrate collaboration among sectors, including public health, government, healthcare, etc. and among multiple nonprofit agencies/institutions/departments/governmental entities.
- Prioritize engagement of residents from the communities served.
- The Weld Trust values evidence-based best practices, but also encourages innovative solutions.
- Leverage additional funding as well as community assets.
- Have a demonstrable sustainability plan that will enable the work to continue beyond the funding period.
- Provide an established plan for evaluation including measurable outcomes. Explain the way in which you will know that you have been successful in achieving the impact you intended. Identify the specific manner in which the outcomes you propose impact the funding strategy of TWT listed above.



### **Guidelines**

Eligible applicants must be tax-exempt organizations under Internal Revenue Service 501(c)(3) or operate under the fiscal sponsorship of a tax-exempt nonprofit, including schools and public organizations.

PLEASE NOTE: Only nonprofit organizations, schools, and government agencies located in Weld County or whose program is exclusively for Weld County residents in the areas of health or education are eligible to apply.

### **How to Apply**

Interested applicants must submit a letter of inquiry via our website no later than January 10, 2022, 5:00 p.m. MST. **Please do not submit a full proposal unless invited to do so.** If the LOI is accepted, an application form will be made available. Those invited to submit a full proposal will be notified on or about January 31, 2022.

Completed applications with supporting documents must then be submitted to The Weld Trust no later than March 4, 2022, 5:00 p.m. MST. Final grant decisions will be announced on or about June 1, 2022. Funding will be in late June with the grant period beginning July 1, 2022.

### **Letter of Inquiry Content and Parameters:**

**Please complete the Letter of Inquiry on our website at [www.WeldTrust.org/grants/](http://www.WeldTrust.org/grants/). The LOI application period is December 16, 2021 – January 10, 2022.**

- Clearly state the name of your organization or group, name of your Director or Leader, and contact information.
- Affirm your status as a nonprofit organization as determined by the IRS, or operate under the fiscal sponsorship of a tax-exempt nonprofit, including schools and public organizations.
- State the intended service provision to include intended number of people served, proposed outcomes, and funding level requested to meet those outcome goals.
- Affirm that the request falls within the funding priority noted above.
- Affirm that all activities for which you are seeking funding will be located in Weld County or will be exclusively for the benefit of citizens of Weld County, Colorado.

*Please note that the senior leader for an Applicant Organization such as CEO, President, Superintendent, Provost, Executive Director, etc. will be required to submit a Letter of Support along with the full proposal should an invitation for such be extended.*
